PROMOTION DESCRIPTION: The Belmont Stakes \$150,000 Sweepstakes (the “**Sweepstakes**”) begins on March 27, 2018 at 12:01 a.m. Eastern Time (“**ET**”) and ends on May 18, 2018 at 11:59 p.m. ET (the “**Promotion Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of New York Racing Association, P.O. Box 90, Jamaica, NY 11417 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Open only to legal United States residents residing in the forty-eight (48) contiguous United States and Washington D.C. who are twenty-one (21) years of age or older. Employees, officers and directors of Sponsor, its parent, subsidiaries, affiliates, agents, successors, assignees, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize. Additionally, employees of State Racing and Wagering Board licensees and their immediate family members are ineligible to participate in the Sweepstakes. Sweepstakes is void in Alaska, Hawaii and where prohibited by law.

- b) Ticket Purchase: During the Sweepstakes Period, go to the Website, select the “Tickets” tab to be re-directed to our official ticket seller, or visit ticketmaster.com to purchase tickets to the 150th Belmont Stakes (the “**Race**”) scheduled to take place at approximately 6:30pm EST on June 9, 2018 and you will automatically receive one (1) entry into the Sweepstakes for each Race ticket you purchase up to a maximum of twelve (12) Race tickets.

- c) NYRABets Entry: Existing members of NYRA Bets will automatically receive five (5) entries into the Sweepstakes if they have placed any wager in any amount between June 10, 2017 and the end of the Promotion Period and new NYRA Bets members will automatically receive five (5) entries in the Sweepstakes if they set up a NYRA Bets account during the Promotion Period. It is free to set-up a NYRA Bets account. For more information, visit NYRAbets.com.
- d) Mail-In Entry: To enter without setting up an account, placing a wager and/or purchasing Race tickets, on a 3x5 piece of paper, hand print full name, email address, complete mailing address (including city, state and zip code), your date of birth and telephone number. Mail this completed card in a first-class stamped envelope to: Belmont Stakes \$150,000 Sweepstakes, PO Box 10278, Rochester, NY 14610. Limit one (1) request form per outer mailing envelope. All requests must be postmarked by May 18, 2018 and received by May 24, 2018. No copies, facsimiles or mechanical reproductions will be accepted. Sponsor assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible or postage due entries or mail. A mail-in entry will be equal to twelve (12) entries into the Sweepstakes. Limit two (2) mail-in entries per person.

The Website's database clock will be the official timekeeper for online entries in this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. **Limit twenty-four (24) entries per person throughout the Promotion Period regardless of method of entry.**

WINNER SELECTION AND NOTIFICATION: At the end of the Promotion Period, one (1) Grand Prize winner will be randomly selected from all eligible entries received during the Promotion Period. The potential prize winner will be notified by telephone and/or mail and/or e-mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. PRIZE/APPROXIMATE RETAIL VALUE:

One (1) Grand Prize is available. The Grand Prize consists of a trip for the winner and one (1) guest from June 5, 2018 through June 10, 2018 to attend the 2018 150th Belmont Stakes taking place on June 9, 2018 at Belmont Park in Elmont, NY. Prize includes: a) round-trip economy class airfare for the winner and one (1) guest from a major airport near winner's residence (as selected at the sole discretion of Sponsor) to the Elmont, NY area; b) five (5) nights hotel accommodations (one room, double occupancy); c) on-site hospitality tickets for the winner and his/her guest at Belmont Park for the duration of the Belmont Stakes Racing Festival (June 7-9); d) a gift basket consisting of Belmont Stakes merchandise and selected gift cards; e) admission to various Belmont Stakes events during the stay, as selected by Sponsor; and f) a chance for the winner **ONLY** to select his choice for the winning horse of the 150th Belmont Stakes for a chance to win \$150,000 (the "**Winner Pick**"), as described below. The approximate retail value of the Grand Prize is \$6,450. Actual retail value of the Grand Prize shall depend on winner's point of departure, destination, fare fluctuations and date and time of travel as well as weather.

Winner's Pick: Prior to the official running of the 150th Belmont Stakes on June 9, 2018 at a time to be determined at the direction of Sponsor and no later than one (1) hour prior to post time of the Race, the Grand Prize winner must provide a representative of Sponsor with his/her pick of which horse (the horse's name and number) will win the Race (the "**Winner's Horse**"). Should the Winner's Horse be named as the official winner of the Race by the Race officials, the Grand Prize winner will receive \$150,000 (the "**Winner's Pick Prize**"). In the event there are five (5) or fewer horses that actually run in the Race, the Winner's Pick Prize will not be awarded.

The winner's guest must be twenty-one (21) years of age or older. The guest must also sign and return a Liability/Publicity Release prior to ticketing of travel. Winner and his or her guest must travel together on the same itinerary and possess all required official government required travel documents, including a valid photo ID. Air transportation tickets are non-refundable/non-transferable and may not be valid for upgrades and/or frequent flyer miles.
